TOTAL FEES

GENERAL: Electrical work shall not be started until the application for permit has been filed. All installations shall be in conformance with the Electrical Code. **No work shall be concealed until it has been inspected.**

When ready for an inspection, call the Building Department at (248) 449-9920 24 hours in advance. You must provide address and permit number.

EXPIRATION OF PERMIT: A permit remains valid as long as work is progressing and inspections are requested. A permit shall become invalid if the authorized work is not commenced within six months after issuance or work is suspended or abandoned for a period of 6 months. **A PERMIT WILL BE CANCELED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CANCELED PERMITS CANNOT BE REFUNDED OR REINSTATED.**
